# STEPS FOR OBTAINING A MICHIGAN SCHOOL COUNSELOR CREDENTIAL THROUGH EMU

Based upon the coursework, degrees and examinations you completed, you may be eligible for one or more of the following school counselor credentials:

- Preliminary Employment Authorization as a School Counselor (PEASC) Valid for 3 years and non-renewable
- School Counselor Endorsement on a Teaching Certificate (NT)
- School Counselor License (SCL) No teaching certificate required

The table below identifies the specific requirements for each of these credentials.

IMPORTANT NOTE: Regardless of when you graduated with your master's degree in school counseling, you must meet the <a href="mailto:current">current</a> coursework requirements in place when you <a href="mailto:apply">apply</a> for the school counseling credential. This is not an EMU policy. Rather, it is a state policy. As such, it is non-negotiable.

# STEPS TO OBTAINING A MICHIGAN SCHOOL COUNSELING CREDENTIAL

### Step 1: Create a Michigan Education Information System (MEIS) Account

Visit <a href="https://cepi.state.mi.us/meis/login.aspx/">https://cepi.state.mi.us/meis/login.aspx/</a> and follow the links on the screen to create a Michigan Education Information System (MEIS) account. When you complete the MEIS registration process, you will see a screen with your account ID, login, and temporary password. Follow the link listed on the bottom of the screen to set your MEIS password. Be sure to print out or keep documentation of your MEIS account information for future reference.

# Step 2: Register with MOECS (Michigan Online Educator Certification System)

Once you have established a MEIS ID, please visit <a href="https://mdoe.state.mi.us/MOECS/Login.aspx">https://mdoe.state.mi.us/MOECS/Login.aspx</a> and, on the login screen, sign in with your MEIS user ID and password. Follow the steps to self register with MOECS. On the registration page, you will be asked to provide your MEIS account number, which is included in the email that you received from MEIS.

### **Step 3: Apply for Certificate in MOECS**

Once you have signed in with MOECS successfully, you will be asked to complete the demographic information and once it is saved, you will see the links on the left navigation panel. Choose the link that is appropriate for you and follow the steps to apply for the PEASC, SCL, or NT endorsement. If you do not see the credential you are looking for, contact 517.373.3310.

## Step 4: University/College review/approval

After you have applied for the certificate/license, your application will be submitted to the institution that you identified in the application process via MOECS for review and approval. Please email Dr. Parfitt at <a href="mailto:dparfitt@emich.edu">dparfitt@emich.edu</a> to notify her that you have submitted the application as she handles school counselor application approvals for EMU as an institution.

### **Step 5: Online Fee payment**

Once your application is approved by the institution in MOECS, you will receive an email with a link for you to pay the fee online using credit/debit card or you can do so by logging into MOECS using your user ID and password, and clicking on the "pending payment" hyperlink on the home page.

### **Step 6: Issuance of Certificate**

Once the fee is paid, your application will be approved by the MDE and the certificate will be printed and mailed to the address that you provided in your demographic information within 5 business days.

### MAINTAINING A MICHIGAN SCHOOL COUNSELING CREDENTIAL

Once you receive your school counseling credential, you will want to maintain it. The NT certification and SCL credentials are valid up to 5 years and are renewable (3 years for the PEASC & is not renewable) via completion of continuing education credits in accordance with the Michigan Department of Education policy. Continuing education requirements specify a need to complete 180 State Continuing Education Clock Hours (SCECHs) or 6 credits every 5 years, but this varies by certificate type. You will want to check the continuing education requirements for your type of certificate. In addition to completing the continuing education, you will need to apply for renewal.
